Privacy Policy for Coates Data Strategies Website

Your privacy is important to Coates Data Strategies. Please read this privacy notice carefully as it contains important information on who we are, how and why we collect, store, use, and share personal information, your rights in relation to your personal information and on how to contact us and supervisory authorities in the event you have a complaint.

1. Who We Are

Coates Data Strategies LLC (doing business as Coates Data Strategies) collects, uses, and is responsible for certain personal information about you.

2. Children's Online Privacy Protection Act

This website and any products and services offered herein are not intended for persons under the age of 13. Coates Data Strategies does not knowingly collect information from anyone under 13 years of age. Coates Data Strategies prohibits children under the age of 13 from using all interactive portions of this website, including leaving any comments, filling out forms, or otherwise submitting information. Coates Data Strategies will not knowingly collect personally identifiable information from children under 13. If Coates Data Strategies learns it has any information or content from anyone under the age of 13, it will delete that information.

3. The Personal Information We Collect and Use

a. Information Collected By Us

Coates Data Strategies may collect, use, and is responsible for certain personal information that you provide when you voluntarily sign up for e-mail updates, register for a course/workshop, register for a presentation, leave comments, order a service or product, fill out any type of form, access private membership pages, or otherwise contact Coates Data Strategies via an online form or e-mail. The information collected may include your name, e-mail, address, phone number, and/or billing information. You are not required to provide any personally identifiable information to merely access or visit this website.

Coates Data Strategies may collect domain information and "cookies" (small files saved on your hard drive by your web browser) to analyze website performance, track user patterns, save information from your previous visits, and customize your experience.

If your browser sends a "Do Not Track" signal, our website will honor it.

We will ask for your consent to allow us to use cookies. Coates Data Strategies or its third-party vendors may collect nonpersonal information through the use of these technologies. Nonpersonal information might include the browser you use, the type of computer you use, and technical information about your means of connection to this website such as the operating system, the Internet Service Provider, and other similar information. Coates Data Strategies' systems may also automatically gather information about the areas you visit and search terms you use on this website and about the links you may select from within this website to other areas of the Internet. Google Analytics is used for this purpose.

If you are located in the European Economic Area (EEA), we are regulated under the General Data Protection Regulation which applies across the European Union (including in the United Kingdom) and we are responsible as controller of that personal information for the purposes of those laws.

b. Information Collected from Other Sources

We also obtain personal information from other sources, including Thinkific, MailChimp, and ThriveCart.

c. How We Use Your Personal Information

Coates Data Strategies collects such information in order to send e-mails, fulfill orders, deliver services and products, complete customer transactions, oversee promotions, improve website performance, and customer service.

d. Who We Share Your Personal Information With

Coates Data Strategies respects your privacy and will never sell, trade or transfer your personally identifiable information to third parties (beyond what is necessary for fulfilling a customer transaction or for the basic functionality of an online service) without your consent.

We do, however, share your name and delivery address details (when purchasing a course or workshop) with our third-party suppliers and credit card processors which may include Squarespace, MailChimp, Stripe, PayPal, and ThriveCart.

We will not store or collect your payment card details. That information is provided directly to our third-party payment processors whose use of your personal information is governed by their Privacy Policy. These payment processors adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council.

This data sharing enables the delivery of goods and services requested or ordered by you. Those third-party recipients are based outside the European Economic Area. For further information including on how we safeguard your personal data when this occurs, see Transfer of your information out of the EEA.

Coates Data Strategies may release personal information to enforce its Website Terms and Conditions of Use, other Terms and Conditions, manage its business, protect users or the general public, or to otherwise comply with legal obligations.

If you grant Coates Data Strategies your explicit permission, it may also use personal identification information for internal or external marketing and promotional purposes.

On occasion, Coates Data Strategies may collect personal identification information from you in connection with optional special offers or promotions. Coates Data Strategies will share such information with necessary third parties for the purpose of carrying out the special offer or promotion. We will ask for your consent to such disclosure and use of such information, prior to your participation in the special offer or promotion.

We will not share your personal information with any other third party.

e. Whether Information Has to Be Provided by You and Why

We do not require you to provide any personal data in order to access the public areas of our website. We will inform you when we collect it whether you are required to provide the information to us.

f. How Long Your Personal Information Will Be Kept

We will hold all non-client personal data until you let us know you would like for us to delete it or unsubscribe from our marketing contacts, which you are free to do at any time. We will hold all client and customer personal data in our files for six years.

g. Reasons We Can Collect and Use Your Personal Information

Coates Data Strategies collects and uses your personal information to send e-mails, fulfill orders, deliver services and products, complete customer transactions, oversee promotions, improve website performance, and customer service.

4. Use and Transfer of Your Information Out of the EEA

This website is operated in the United States and third parties with whom we might share your personal information as explained above are in the United States. If you are in the EEA or elsewhere outside of the United States, please be aware that any information you provide will be transferred to the United States. By using this website, participating in any of its services and/or providing your information, you consent to this transfer.

These countries do not have the same data protection laws as the United Kingdom and EEA. While the European Commission has not given a formal decision that United States provides an adequate level of data protection similar to those which apply in the United Kingdom and EEA, any transfer of your personal information will be subject to the derogation in Article 49 permitting non-repetitive transfers that concern only a limited number of data subjects, as permitted by Article 49 of the General Data Protection Regulation that is designed to help safeguard your privacy rights and give you remedies in the unlikely event of a misuse of your personal information.

5. Your Rights

- Object in certain other situations to our continued processing of your personal information
- Otherwise restrict our processing of your personal information in certain circumstances

You may also have the right to claim compensation for damages caused by our breach of any data protection laws.

We also have procedures in place to deal with any suspected data security breach. We will notify you and any applicable authorities of a suspected data security breach where we are legally required to do so.
